I. Policy

Changes of Curricula, Courses, Catalog, and/or Semester Schedule

II. Purpose

Provide students of Southside College of Health Sciences (SCHS) with the guidelines related to changes in curricula, courses, catalog and/or semester schedule.

III. Scope

This policy applies to all students of SCHS.

IV. Definitions

Academic Calendar: The College academic year is defined as three standard terms (Fall and Spring) consisting of 15 weeks plus a final examination week and a Summer term consisting of 14 weeks plus a final examination week. The calendar is subject to change. The latest calendar can be accessed on the College website.

V. Policy Details

The College reserves the right to make appropriate changes without notice in any information, to include procedures, policies, calendars, requirements, programs, courses offerings and schedules, curricula, financial aid and fees, as published in the catalog, website, and in other communications.

In order to assure quality instruction, the College reserves the right to close registration when maximum enrollment has been reached. The College reserves the right to make changes in schedules and/or faculty when necessary.
