I. Policy

Changes of Curricula, Courses, Catalog, and/or Schedule.

II. Purpose

The purpose of this policy is to provide students of Southside College of Health Sciences (SCHS) with the guidelines related to changes in curricula, courses, catalog and/orr schedule.

III. Scope

This policy applies to all students of SCHS.

IV. Definitions

Academic Calendar: Academic Calendar for the Nursing (curriculum prior to Fall 2023), Radiologic Technology, and Diagnostic Medical Sonography programs consists of two (2) standard Semesters (fall and spring), which contain fifteen (15) weeks of academic instruction plus one (1) week of final examinations (together 16 weeks total), which when combined defines a thirty-two (32) week Academic Year. In addition, these programs include a summer term. The Academic Calendar for the Nursing curriculum effective Fall 2023 consists of four (4) non-standard, 8-week Terms, which is inclusive of the final examination period, which when combined defines a thirty-two (32) week Academic Year. In addition, this program includes an 8-week summer Term.
