To provide the student academic classification and enrollment standards.

## III. Scope

For all faculty, staff and students at Bon Secours Memorial College of Nursing.

### IV. Definitions

**Credit/Credit Hour:** The number of credits awarded for a given course is determined by the number of lecture, lab, and/or clinical hours spent in class.

## V. Policy Details

Student academic classification is based on the number of credit hours completed including transferred hours. Classification is as follows:

| Classification | Credits     |
|----------------|-------------|
| Freshman       | 0 – 29      |
| Sophomore      | 30 – 59     |
| Junior         | 60 – 89     |
| Senior         | 90 or above |

### **Normal Course Load:**

Students may enroll for a maximum of 19 credit hours during fall and spring semesters and 12 credit hours during the summer semester. A student who wishes to exceed the normal course load must seek approval from the Dean of Academic Affairs or Program Director.

### **Credit/Credit Hour Formula:**

The following formula is used to calculate credit hours: One semester credit is equal to:

One hour of lecture per week for a semester or the equivalent number of hours. Two hours of lab per week for a semester or the equivalent number of hours. Three hours of clinical per week for a semester or the equivalent number of hours
